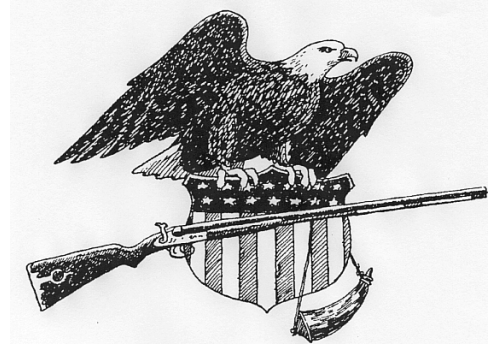

Greetings Exhibitors,

Welcome to the Thirty-Ninth Annual Bangor Gun Show. PLEASE NOTE: WE HAVE MOVED!!! Fees and policies at the Cross Insurance Center have make it financially impossible for us to return to that location without increases in table cost and admission fees. This year's show will be at the Anah Shrine. We will be able to reduce the table costs and the gate fee. We will also be able to operate our own kitchen. NO MORE \$5.00 HOT DOGS!

This year's show will be held Saturday, October 8<sup>th</sup> and Sunday, October 9<sup>th</sup>. Set up will be Friday, October 7<sup>th</sup> from 1:00 to 9:00 PM. There will be fewer tables available than before. Please respond as soon as possible for reservations. Priority will be given to those displaying firearms, ammo, optics and gun parts.

**PLEASE READ THE SHOW RULES ON THE BACK OF THIS PAGE.**

- We will require full compliance with all BATFE rules in effect at the time of the show; some requirements of the City of Bangor; and those of our insurance carrier.
- We will try to provide expanded opportunities for both exhibitors and attendees by permitting some non-FFL sellers to set up at the show. All modern firearms bought, sold or traded will be processed via FFL holders. There will be a few FFL holders available to process your transactions for a fee. Please read the show rules on the back of this page.
- Full security coverage will be available from 1:00 PM Friday until 5:00 PM Sunday. Coded stickers will be provided to FFL dealers to affix to firearms sold at this show.
- Tables are \$60. **Payment must accompany table request.** Deadline for table requests is September 23rd. Any request received after that will be placed on a waiting list and will be assigned tables, if available at \$65 each. A table request/contract is attached.
- Motels: A listing of nearby motels and rates will be sent with your table reservation confirmation.

# SHOW RULES – 2016

## THIRTY-NINTH ANNUAL BANGOR GUN SHOW

**EXHIBITORS:** You must possess a current, valid Federal Firearms License to buy, sell, trade, or in any way traffic in modern firearms at the Bangor Gun Show; or process your transactions through one of the licensed exhibitors at the show. FFL holders processing such transactions may charge a fee for their services. Dealers in antique firearms are exempt from this requirement only when dealing in antique firearms. (See BATFE definition of antique firearms.) **Provide a copy of your current FFL with your application.** If your license expires between the time you mail in your application and the date of the show, bring a current license with you to the show.

**SETUP:** Dealers must be open for business each day by 9:00 a.m. and remain open throughout the show hours. **Do not tear down your display prior to 2:00 p.m. Sunday.** Show hours for the public are 9:00 a.m. to 5:00 p.m. Saturday and 9:00 a.m. to 2:00 p.m. Sunday. If you have not set up by 8:30 a.m. Saturday and you have not contacted the Show Coordinator, your table may be sold. If we are able to re-sell your table you may be reimbursed.

**TABLES AND COVERAGE:** All tables are 8' by 2 ½' and must be covered with an appropriate tablecloth (not provided by PCCA). The use of all tables is the property of PCCA and may not be sold, transferred or shared without written permission of PCCA. Location of table assignments is at the discretion of the PCCA.

**PROHIBITED ITEMS:** Jewelry, coins, cameras, fishing equipment, and flea market type items are prohibited. If you have doubts as to the appropriateness of specific items, please ask.

**AMMUNITION:** All ammunition must be in a container. This does not necessarily mean the original box, but the intent is that ammunition not be left open and loose for anyone to have easy access.

**GUN POWDER:** No black powder allowed. Any display of smokeless powder (up to 20 pounds per vendor) must be in approved one-pound containers. Smokeless powder displays by any vendor in excess of 20 pounds are not permitted. No vendor may display more than 5 pounds of Pyrodex and it must be in sealed containers.

**INSURANCE:** Our insurance carrier states that all exhibitors at the Bangor Gun Show would be well advised to carry liability insurance to cover any unforeseen incident related to the conduct of business. The Bangor Gun Show's policy does not extend to individual exhibitors. Insurance is recommended in the amount of \$1,000,000 with the show promoter (PCCA) named as an additional insured.

**SAFETY:** Security coverage will be provided continuously from 1:00 p.m. Friday to 3:00 p.m. Sunday. **LOADED FIREARMS WILL NOT BE PERMITTED IN THE FACILITY WHETHER BY EXHIBITOR OR VISITOR, REGARDLESS OF CONCEALED FIREARMS PERMITS.** We will require all firearms to be rendered inoperable with safety ties and magazines removed. Also, no pets will be allowed in the facility.

**BADGES:** Each dealer will be provided badges (usually two or three), which must be worn at all times. If you have a special need for additional badges, please state the reason on your request or see the Show Coordinator. As an exhibitor you are responsible for anyone using a badge assigned to you. The control over badges is for your protection and for the protection of your merchandise.

**TAGS:** A supply of coded tags will be provided for your use in identifying items sold to the public. Please have some idea of the number of tags you will need. **You will need a stapler to attach the tags to firearms.**

**CANCELLATIONS:** Cancellations must be received in writing no later than two weeks prior to the show. Deposits will be refunded if the show is a sell-out and PCCA can re-sell the tables.

**SECURITY:** We will have private security personnel present throughout the show. This will include overnight security. Regardless, the Anah Shrine, the City of Bangor, the Penobscot County Conservation Association or the Show Coordinator is not responsible for loss or damage to the dealer's/exhibitor's merchandise. The dealer/exhibitor specifically agrees to defend and hold harmless the Anah Shrine, the City of Bangor, the Penobscot County Conservation Association and the Show Coordinator from all claims for bodily injury and/or property loss or damage arising out of the dealer's/exhibitor's participation in the show.

**CONDUCT:** Dealers/exhibitors will not solicit purchases from the public in the parking lot, show facility entrances, snack bars or firearms check in areas. The use of alcohol is not consistent with firearms safety; therefore, no alcoholic beverages will be present or consumed at the Bangor Gun Show. Any incidence of unprofessional or unethical business practices or conduct or violation of state, local or federal laws will be considered due cause by the PCCA for removal from the show and refusal of space for any future show.

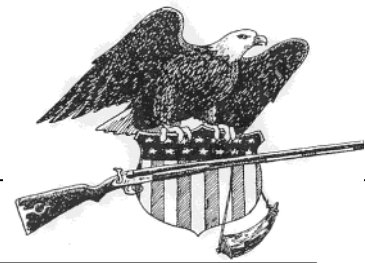
